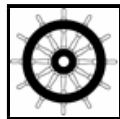

## Product description

"GLAVA LYDFELLEPLATE 2000"

Non-homogenous product composed of glass wool with glass fibre veil on one side. The glass fibre cloth is applied to the glass wool by means of an adhesive.

Glass wool characteristics:

Nominal density (approx): 35 kg/m<sup>3</sup>

Nominal organic content (approx.): 7.5%

Glass fibre veil characteristics:

Nominal thickness: 0.150 mm

Nominal area weight (approx.): 125 g/m<sup>2</sup>

Nominal organic content (approx): 5.3 %

Weight of adhesive per unit area: 25 g/m<sup>2</sup>

## Application/Limitation

Approved for use as non-combustible material.

The material shrank/collapsed during the non-combustibility test.

The product may be used as an integrated part of approved fire resisting divisions only when tested as such.

Insulation materials with surface layer have to be approved for low flame spread characteristics (test for surface flammability) according to the Marine Equipment Directive and bear the Mark of Conformity.

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

Each product is to be supplied with its manual for installation, use and maintenance.
