## Product

### Product description:

Weber Steinlim is a dry premix adhesive mortar based on cement, sand and additives. When mixed with water it is a ready-to use mortar/adhesive for interior and exterior use on both floor and wall.

Weber Steinlim is used for gluing factory-made calibrated and natural uncalibrated stones, natural and concrete bricks. The composition of the product reduces the risk of discoloration of natural stones and formation of lime precipitation. Weber Stenlim can be used for installation of electric heating cables.

Specific data for the product composition are provided by the manufacturer. They represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on registered EPDs according to EN 15804, Ostfold Research databases, ecoinvent and other LCA databases. 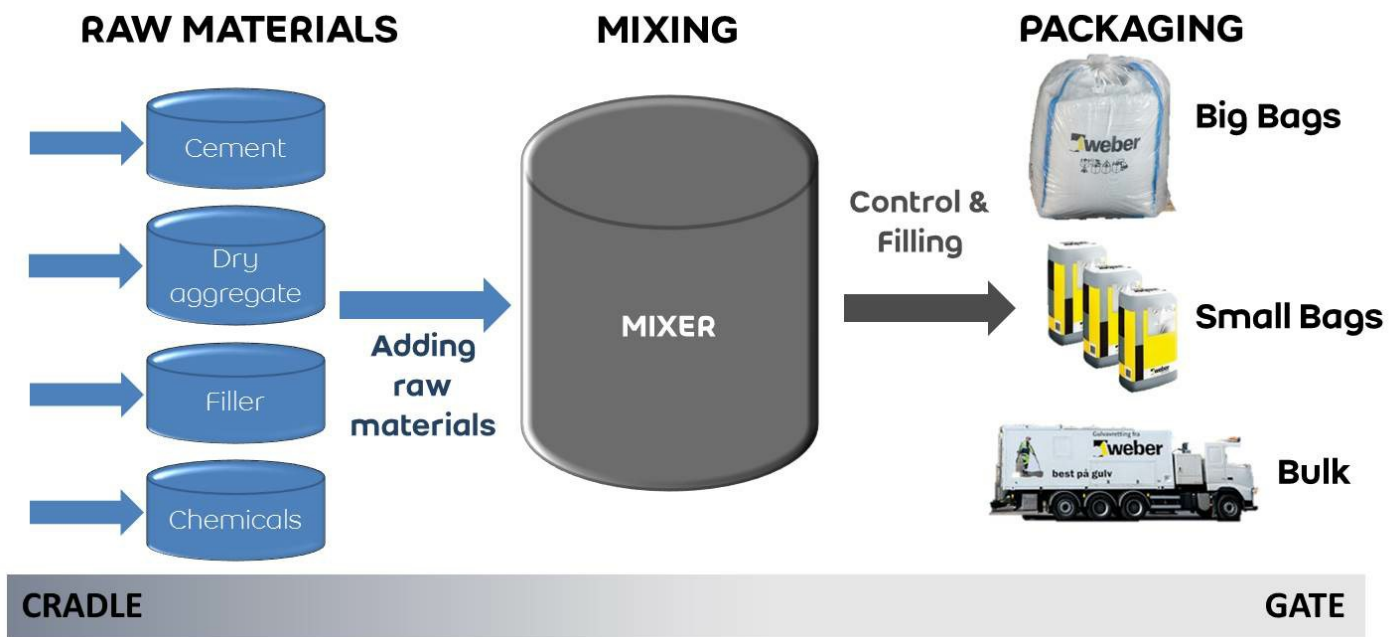
### Reference service life, product

### Reference service life, building

**System boundary:**

All processes from raw material extraction to product from the factory gate are included in the analysis (A1-A3). In addition, transportation to a central warehouse placed in accordance with guidelines issued by the EPD Norway (A4) is included.

The flow chart below illustrates the system boundaries for the A1 to A3 part of the analysis.



**Additional technical information:**

2 kg dry mortar gives approximately 1 liter of final product. The remaining powder is classified as hazardous waste. Cured material is inactive and not classified as hazardous waste and may be disposed as construction waste to disposal or recycling. The packaging properly emptied is not classified as hazardous waste.
